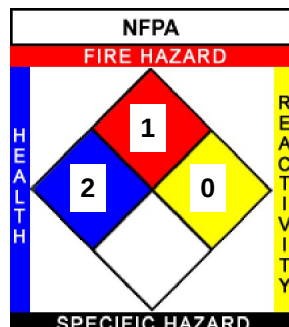

## 4 FIRST AID MEASURES

**Inhalation:** Remove from exposure and get fresh air. Keep warm and at rest. Get medical attention immediately if artificial respiration is required.
